

Ticket Credits for multiple bookings

Option available for Qantas customers holding a valid Qantas '081' ticket issued on/before 30 September 2021.

1. Discuss with your customer if they would like to take advantage of this offer to use their ticket credit across multiple Qantas journeys.
Once your customer chooses this flexible credit option, they forfeit the ability to obtain a refund on the credit (if they were entitled to one under their original fare rules).
2. Create a new PNR with a Pseudo flight: QF 9331 SYD / ZZF
Flight is available in Y class only.
3. Reissue your customer's eTicket to the Pseudo flight – all flight coupons to be reissued into one flight coupon of the Pseudo flight.
The flight coupon of the eTicket should be for the airfare only and rounded up to the next dollar. No cents should be shown.
Raise an EMD for taxes to be refunded via BSPLink. Please include in your comments TAX REFUND ONLY to ensure we prioritise these refunds.
4. Once reissue of the eTicket is completed, no further action required until your customer is ready to start using their credit.
5. Book flights required by your customer. If there is residual credit, book a Pseudo flight for any residual credit to be held on the eTicket. Round up to the next dollar. No cents should be shown.
Example:
QF 401 Q 20MAR
SYD/MEL QF402 Q 27MAR
MEL/SYD QF 9331 Y
30MAR SYD/ZZF
6. Reissue the SYD/ZZF coupon of the eTicket. Customer will need to pay for taxes associated with the rebooked flight(s). No tax applies to the Pseudo flight.
7. Customer flies SYD-MEL-SYD.
SYD/ZZF coupon available with remaining funds until your customer is ready to book their next journey.
8. Repeat process until all funds have been fully utilised.
Travel must be completed by 31 December 2023 otherwise the credit will be forfeited.
