

1. Information on how to enter forms part of the terms and conditions of entry. Entry into the promotion is deemed acceptance of these terms and conditions.
2. The promoter is Qantas Airways Ltd of 401 King St, Hammersmith (telephone number 0208 846 0466) (**Promoter**).
3. The promotion commences at 7.00am (BST) on 23 May and closes at 11.59pm (BST) on 2 June 2014 (**Promotion Period**).
4. Entry is open only to residents of the United Kingdom only who are over 18 years of age (**Eligible Entrants**), excluding directors, management, employees and their immediate families of Qantas Airways, Kerzner International, Sky, Recipe, NDL Group, 20th Century Fox Film Corporation and their related bodies corporate and registered travel companions of employees of Qantas Airways and its related bodies corporate.
